## DEFINITIONS

It is acknowledged that not all applicants will be familiar with all terms used in the various documents within the Register

The following is an overview or description of various references made.

<b>APPLICATION FORM</b>	The document completed in expressing an interest as EOI.
<b>CERTIFICATE OF ADMITTANCE</b>	The Certificate an individual holds on their award of Chartered status.
<b>CHARTER</b>	The document conferring recognition of the Award by the Privy Council by which the Chartered Status can be awarded.
<b>CODE OF CONDUCT</b>	The Livery code of conduct setting out the behaviours expected from all those not only in the Livery but by all those individuals holding the Charter. A self-declaration in respect of criminal records, bankruptcy, County Court Judgements, Individual Voluntary Arrangement, disqualified directors and other professional association applications.
<b>CONTINUING PROFESSIONAL DEVELOPMENT (CPD)</b>	The process by which an individual demonstrates their ongoing professional development as detailed in the Charter documents.
<b>ENVIRONMENTAL CLEANING PROFESSIONAL.</b>	The status by which someone holding Chartered status is referred to.
<b>EXPRESSION OF INTEREST (EOI)</b>	The initial application by an individual to demonstrate an interest in pursuing their entry into the Charter.
<b>INDIVIDUAL PATHWAY</b>	The process or route by which someone who does not hold the relevant professional qualifications or charter status from another field may apply to join the register.
<b>KEY ELEMENTS</b>	The detailed provisions of competencies from which Charter status can be established.
<b>OFFICERS</b>	The Master. The Deputy Master, the Senior Warden, The Junior Warden of the WCEC
<b>REGISTER</b>	The record of all those who have achieved Chartered status

<b>REGISTRANT</b>	As the holder of the Charter, the Worshipful Company of Environmental Cleaners is referred by this term throughout the formal documents.
<b>STANDARD PATHWAY</b>	The process by which someone holding the relevant professional qualifications or charter status from another field may apply to join the register.
<b>SELECT COMMITTEE</b>	The members of the Livery Education Committee who form the sub-group for The Charter Register.
<b>SENIOR LEVEL</b>	The level or position an individual holds within their current and/or past employment that demonstrates their seniority of experience and competence.
<b>STRATEGIC APPROACH</b>	Responses that provide a logical, coherent and balanced structure
<b>WCEC</b>	Worshipful Company of Environmental Cleaners.
